Object : INSTALLATION OF SGS PROTECTIVE SYSTEM ON HAULOTTE MACHINES

To whom it may concern,

With regard to the PROTECTIVE MEWP SHIELD intended for use on Haulotte scissor lift and vertical masts:

We understand that the Device is intended to improve safety use of the Machine. The Device is not fully integrated with the Machine and Haulotte cannot ascertain it will properly interface with the Machines.

The PROTECTIVE MEWP SHIELD Device may be installed, under the following terms and conditions:

- the Device shall be installed only on Haulotte Machines designed only for Australia and New Zealand (AS/NZS 1418.10 only).
- Any and all verification/test remain the sole responsibility of PROTECTIVE, the owner and/or the user of the Machine.
- Haulotte is not liable for the Device's quality, performance, reliability, or compliance with any regulation, nor does Haulotte validate the content of the Device's documentation: this remains the sole responsibility of PROTECTIVE.
- All necessary PROTECTIVE references are to be kept with the Machine at all times, along with the Operators Manual and Maintenance Manual.
- The owner remains solely responsible for the decision to mount the Device on the Machine.
- The installation of the Device onto the Machine must be completed by competent personnel, following the manufacturer's references and specifically the schematic provided by PROTECTIVE. PROTECTIVE must provide the owner of the machines with all necessary information at any time.
- The Device must be fitted with the OEM Control Box system provided with the Machine (check with your Customer service contact for such references).
- Any change in documents or versions, even if brought to Haulotte's attention, will be the sole responsibility of PROTECTIVE.
- A complete test and pre-inspection of the Machine and/or the Device must be completed by PROTECTIVE, before and after installation of the Device on the Machine.
- The user must be familiar on the use of the Device.

Your attention is brought on the fact that improper interface may affect critical safety systems and result in serious injury.

Use of the Machines:

Follow all safety rules and instructions from the User's Manual and local regulation.

The Device is not intended to replace proper inspection, use and/or maintenance of the Machine, nor does it replace adequate training, instruction, or proper use of the Machine in its working environment. The use of the Machine remains the sole responsibility of the Owner and/or user of the Machine.
